The Northeastern Skating Association (NSA) is an organization that was established in the 1930's to teach, develop, and promote the sport of Speedskating in the New England area.

As a member of the National speedskating union - The Amateur Skating Union - the NSA and its member clubs are able to provide speedskating instruction to skaters of all ages and abilities. Instruction is provided at all regular club sessions and races are held during the winter skating season.

The ultimate goal of the NSA is to develop potential Olympic speedskaters but, recreational speedskating is a large part of the local programs.

While the NSA likes to encourage membership, skating lessons are open to non-members as well. Annual membership fees are as follows:
